

Agreement Regarding  
2007 Federal Columbia River Power System Fish Operations

WHEREAS the Confederated Tribes of the Warm Springs Reservation, the Nez Perce Tribe, the Confederated Tribes of the Umatilla Indian Reservation, the Confederated Tribes and Bands of the Yakama Nation, the Confederated Tribes of the Colville Indian Reservation and Bonneville Power Administration (“The Parties”) and others are actively engaged in remand collaboration pursuant to *National Wildlife Federation v. National Marine Fisheries Service (NWF v. NMFS)*, Cv. 01-640, and in discussions regarding a long term agreement for the operation and mitigation of the FCRPS;

WHEREAS the parties recognize that long term operation of the system is being addressed through the ongoing remand in *NWF v. NMFS* and long term agreement discussions;

WHEREAS the Federal Agencies believe that the FCRPS should be operated in 2007 with respect to spill as required by the Court with respect to 2006 operation except for changes to reflect the anticipated structural improvements at two facilities;

WHEREAS, the Tribes contend that some additional changes to spill and other measures are appropriate;

WHEREFORE, to resolve this disagreement, the Parties agree as follows:


- The Federal Agencies shall operate the FCRPS in 2007 as described in Attachment 1 (which is incorporated herein by reference). To the extent not specified in Attachment 1 the operations shall be consistent with the 2004 Biological Opinion. The Parties agree that these operations provide additional and adequate interim protection for ESA-listed fish for 2007.
- In the event that the District Court requires or desires confirmation of the Tribes’ support for these 2007 FCRPS operations and/or the project funding commitments in Attachment 2, the Tribes shall support the above-described operations in any statements to the Court. Even if not required to do so, the Tribes will indicate their support for these operations and project commitments in 2007 to the Court and support their implementation in all forums.
- The Tribes and Columbia River Intertribal Fish Commission, and their staffs, will not provide direct or indirect support for any other party’s position in any legal proceeding conducted to determine what 2007 FCRPS operations will be implemented and will not provide support for other parties’ efforts to implement operations in 2007 that deviate from those described in Attachment 1.
- Bonneville Power Administration will also provide interim funding for certain tribal projects described in a separate exchange of letters with the tribal chairs, which include actions benefiting ESA-listed fish. The letters setting forth the project funding commitments are, by this reference, part of this agreement and are Attachment 2.

This Agreement addresses 2007 operations only, and does not provide a precedent for any future proceedings or endorsement of these operations for the long term operations of the federal dams.







**2007 Operations For Lower Snake and Columbia River projects**

The following spill operations assume average water conditions in 2007. Unusually high or low water conditions may require deviations from these operations.

In water years when the Snake River projected seasonal average (April 3 – June 20) flow is greater than 70kcfs, transportation will be initiated at Lower Granite Dam no earlier than April 20 and no later than May 1. The seasonal average flow projection will be based on the Corps' STP model and the April final forecast. The actual start date will be decided through the TMT process as informed by the in-season river conditions (e.g. river flow and temperature) and the status of the juvenile Chinook and steelhead runs (e.g. percent of runs having passed the project). In exceptionally low water years, when the projected seasonal average flow is less than 70kcfs, the start date of transport would be April 20.

In water years when the projected seasonal average flow is greater than 70kcfs, transportation will be planned to start 8 days and 11 days after the Lower Granite Dam start date for Little Goose and Lower Monumental dams respectively. The actual start date at those dams will be further considered through the TMT process depending on in-season river conditions and the status of the juvenile Chinook and steelhead runs.

Studies Review Work Group and Fish Facility Review Work Groups will determine final 2007 biological test program and spill patterns for testing and operation.

All other operations not specified in the table above will be consistent with the operations identified in the 2004 FCRPS Biological Opinion; however, flood control operations at Libby Dam are under review. Concerns about potential risks to public health and safety are currently being assessed, and the Corps may decide an operation in 2007 that differs from the interim VARQ operation is necessary.

In addition, BPA and the Tribe will work together to initiate the work necessary to allow for construction of the Northeast Oregon Hatchery consistent with meeting the summer instream work window which begins on July 1, 2007. This includes reevaluation of cost estimates (e.g. cost escalation due to postponement of the project), and development of a bid package and final design. In addition, the Tribe will prepare a short management plan for the hatchery linked to ESA recovery goals. It is also agreed that the Tribe and BPA will continue to promote the benefits of NEOH in recovering ESA listed species in an effort to gain NOAA concurrence.
